This deposit and **an annual \$2,500.00** non-refundable deposit will be applied towards the entrance fee upon transfer from the waiting list to Active membership. Your entrance fee (together with 12% HST tax payable) will be that amount prevailing at the time of your acceptance to Active membership.

SOCIAL WAITING FOR ACTIVE

With the acceptance by Uplands of your application for Active membership and payment of a non-refundable deposit, you automatically become a Social member of Uplands Golf Club without voting privileges. Social membership incurs minimal dues, clubhouse assessment and a Food and Beverage assessment.
